The qualifications required for the application process are that the applicant:

- A. is a graduate of a minimum 2200 hour program in massage therapy, encompassing the minimum standard of education as established by the MASSAGE THERAPIST ASSOCIATION OF CANADA, from a university, college or school, regulated or licensed by the respective educational authority of the province or territory of the institution
- B. or has satisfied the MTANS Board that the applicant's educational qualifications are substantially equivalent to the aforementioned 2200 hour minimum standard
- C. successful completion of the OSCE and MCQ Exams.
